Abbreviated Prescribing Information

Name of Product: Regelle Vaginal Moisturising Gel

Presentation: Regelle is a soft white vaginal gel in a single use intravaginal tube.

Indications: Regelle is a vaginal gel intended for the symptomatic relief of vaginal atrophy, dryness, itching, irritation & discomfort.

Dosing and Administration: Intravaginal application. The contents of one applicator to be inserted into the vagina every three days, preferably in the morning. Depending on the level of dryness, Regelle can be used more or less frequently and can be used daily.

Contra-indications: Known allergy to any of the constituents.

Special Warnings and Special Precautions for Use: If irritation persists or develops, consult a Healthcare Professional. Regelle contains no spermicide and will not protect against pregnancy.

Interaction with Medicaments and other forms of Interaction: None known.

Pregnancy and Lactation: Consult your Healthcare Professional before use.

Undesirable effects: Leakage of the gel or an infrequent white residue.

Pack Size: Regelle is available in three different sized packs containing 3, 6 or 12 applicators.
